1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Government Degree College, Kargil is located in the centre of district Kargil and is situated at an altitude of 8500 feet above the sea level and spreads across an area of at 31183.37 square meters of land. Kargil is tribal district and it is known for its harsh cold winters because of which it remains cut off from the rest of the country for at least six months in winters. The temperature dips below -30 degrees during peak winters. Drass sector in Kargil is known to be the second coldest inhabited place in the world. Kargil is a border district and shares the Line of Control with Pakistan due to which many confrontations have taken place in the past.

The Degree College Kargil, college was brought into inception on 31st March 1995 . At the time of its establishment the college had a Gross Student Enrolment of only 25 students but over the years this number has increased tremendously. Today, the Gross Student Enrollment is 2266 which is a great achievement for a population of around 1.42 lakh people. One of the interesting aspects of this increased number is that out of the total number of students who are enrolled here, 69% of the students are girls. The college do provide facilities of Girls Hostel as well as Tribal Hostel with an aim to provide opportunities of girl education and women empowerment.

The college is affiliated with University of Kashmir and is included in the UGC list under section 2(f) 12(b) on 17th March 2005. The college offers courses in Science, Arts and Commerce stream. The college is a model ecofriendly solar college in the state with 10KV solar plant which supplies uninterrupted electricity to the college. The college also offers vocational training courses in traditional Ladakhi craft. In order to cater the needs of working people and those who cannot afford regular academic courses, the college offers them courses through distance mode. IGNOU, MANUU and Distance Education University of Kashmir study centers are functional in the college campus and provide lifelong learning facility to the masses.

Vision

“The college envisions to provide serene environment that stimulates learning and intellectual creativity so that each student develops lifelong learning skills, human values, sense of yearning for perfection and excellence and acquire degree that is relevant and useful so that they can compete through their own capabilities and capacities.”

Mission

- To grow as a centre of generating intellectual wealth by offering high quality, varied and relevant academic programs that foster critical thinking among the youth to create a knowledge driven society.
- To promote and instill the ethics of social, cultural, national and global significance among the youth through higher social interactions and extension programmes that make them enlightened and responsible citizens.

- To ceaselessly audit, introspect and evaluate the existing mechanisms, upgrade them to make them relevant and innovative to achieve educational excellence.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

- An aesthetic Campus on a small plateau. Campus is surrounded by mountains on all four sides giving it the touch of a valley.
- Campus is completely fenced and care is taken to ensure cleanliness on the campus for which proper disposal mechanisms are in place.
- 100% permanent faculties mostly native of Ladakh. Moreover, the new entrants are young and enthusiastic. This new brigade of assistant professors are taking the education standards to pinnacle.
- Campus is equipped with Solar Energy which serves as a good model for the objective of using renewable and green energy.
- EDUSAT has become operational with multiple classes each day for different subjects and students engagement have been quite positive.
- Language barrier is bridged as most of the faculties are native of Ladakh.
- Students are engaged in co-curricular activities such as debates, painting competitions, song and dance, mushaira (Poetry) and games and sports for their holistic development.
- The newly established library building equipped with modern equipments and technologies.
- The botanical garden of its own which is not huge in area but has various varieties of plants including both native and exotic species.
- In order to imbibe research a museum of Geology is established which will help students and researchers educate themselves with the subject in depth.
- As commitment to social justice, there is a significant increase in enrollment of girl students exceeding their strength to almost 69%.
- Students are mentored and taught about how to deal with responsibilities not just within the confines of the college but beyond its four walls.
- Whatsapp groups which have students and staff as members is fully functional. Students do express themselves better through social media. A Facebook page of the college is one of the most hit pages in the district and college website is fully functional.
- NSS activities such as cleanliness drives carried within the campus, also visiting remote villages, educating common masses about cleanliness and hygiene, talks by students to promote literacy in villages and maintaining communal harmony are examples by which the sense of ethical duty for overall development of society as a whole is emphasised.

Institutional Weakness

- The Degree College in Kargil has certainly been game changer in the higher education for the youth considering it as the first institute in Kargil imparting college education but at the same time there are so many stones that need to be unturned in order to accomplish the dreams of the students to pursue higher and better education in their home region.
- The institution was established in 1995 but still PG Courses are not yet introduced in the curriculum. As a result large number of students migrate to other states for higher studies.

- The climatic conditions in the district are most severe and in winters the mercury drops to an average of minus 20-30. Thus, lack of centrally heated facility in class rooms hampers academic activity during peak winters.
- The college land needs to be improved with several infrastructural and a well equipped play ground.
- The college needs facilities like 10 lecture rooms, Geology Block with well equipped Laboratory, Geography Block with well equipped Laboratory, Biochemistry block with well equipped Laboratory, Commerce Block and an Auditorium are the immediate needs of the college.
- Need of more permanent posts in various disciplines: Dependence on academic arrangement and casual appointment every academic year is the major academic weakness of the institute.
- The major weakness of the college is that it is under district plan for financial support but the limited resources with the district plan curtails the infrastructure development of the college since its inception. The college needs to be transferred to state plan for effective development of the college.
- The college is devoid under the scheme of infrastructure grants to college under RUSA 1.0 and 2.0. The inclusion of the college in such Central Schemes will enhance the competency of the college in all sectors.
- Lack of requisite number of sanctioned posts of teaching and non teaching staff is a major constraint for the smooth functioning of the college.
- Lack of infrastructure/grants to conduct minor/major research programs on unique topography/biodiversity of the region.

Institutional Opportunity

- The College is the only institute of higher education has a campus area (31160.8 square meters). The College has used up only 26.59% (8286.2 square meters) of the area. This means that we have land/space enough to add another 73.41% (22874.6 square meters) of educational infrastructure. This is a huge asset. There is an immense scope for the growth of the college.
- The College is yet to take advantages of various schemes from the UGC for development and up gradation of facilities. The college need to be projected as a special college as it's located in the remotest and most backward district, almost 100 percent of the students enrolled belongs to Schedule Tribe category and almost 100 percent of the enrollment belongs to religious minority and the institute is at a distance of few kilometers from the border of India and Pakistan always witnessing the hazards of border conflicts.
- There is an immense scope for starting new courses like, Information Technology, Computer Application, Statistics and skilled oriented courses of economic importance.
- One of the greatest opportunities for the students which came with the introduction of CBCS (Choice Based Credit System) is the Skill Enhancement Course (SEC). The SEC which is offered to the students can be made relevant to them with respect to the topographical, climatic, cultural, economic and aesthetic interest of the area. Further there is great scope for vocational courses. Those Skill Enhancement Courses and vocational courses need to be included which enhances their skills for self employment and self reliance.
- Ladakh is an abode to innumerable medicinal plants that has relevance in budding SOWA-RIGPA (traditional Tibetan medicine) Industry. The college botanical garden need to be expanded and many medicinal plants if introduced in the college campus will enable research among the faculties and the students as well as it will attract many.
- Geological Museum which is established with limited resources and area can further be expanded as Ladakh is considered a vast open research field for the Geologist of national and international repute.

Institutional Challenge

- Challenge to add significantly to infrastructure and to add to the basket of courses including new subjects and PG programs.
- Challenge to maintain the academic pace with rest of the state because of harsh climatic condition and landlocked situation for almost half of the year.
- Challenge to balance the quality of infrastructure and academics with an increasing roll of students year to year.
- Challenge to foster a deep sense of commitment with temporary teaching and non teaching staff upon whom the cloud of job insecurity is always hanging.
- Challenge to control increasing rate of educational migration outside district due to lack of varied subjects, PG Programs and higher education opportunities in the district.
- Lack of adequate number of sanctioned teaching post results in additional academic burden on the faculties and thus reduces the scope for research activities among the faculty members.
- Lack of standard of art indoor and outdoor sports facilities that hampers students excellence in various sports competition at state and national level.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The curriculum is developed by the University of Kashmir (to which the college is affiliated) and faculties of the college do regularly visit academic councils of the university and participate in framing curriculum in different subjects. The College committees are entrusted to review the problems faced by the concerned faculties in effective implementation of the curriculum. Stress is laid to incorporate innovative methods in teaching learning process (e.g. Group discussions, assignments, presentations etc) to make teaching and learning more interactive and interesting.

Monitoring System and periodic meetings are scheduled that ensure the effective implementation of the curriculum.

Teachers are encouraged to participate in seminars/conferences and workshops to update their knowledge base.

The college conducts regular internal tests/assignments in order to assess effective curriculum delivery and transaction. Regular study tour and field visits are the special features initiated by the college.

Time-table and Academic Calendar are followed strictly for class work, internal assessment, examination and evaluation. The college interacts with stake holders from various fields by inviting guest lectures and organizing academic events such as inter-college debates/seminars. UDAAN and Sartup India programs implemented to give opportunities to youths in their career development.

The College offers combinations considering the subjects available at 14 feeding higher secondary schools in the district and combination choices approved by the affiliating university.

Apart from formal education, the college inspires the students for social, moral and ethical services. Further the students are persuaded to learn skills of employment.

The NSS volunteers make cleanness drive and make the other students and common people are made aware of sanitation and its advantages. Every year NSS wing organize collection drive for Red Cross fund, Flag Day contribution for the families of martyred army personals.

Every year class representatives are appointed to bridge the gap between the students and the college administration.

During the last six years, as many as five newsubjects like Travel and Tourism Management, Geology, Geography, Biochemistry and Sociology has been introduced in the college. Subjects like Earth Science (Geology and Geography) was introduced considering the rich geological resources available in the Ladakh region being the reservoir of Himalyan range.

Teaching-learning and Evaluation

- 100% transparency in admissions which is open to scrutiny and notified through print and electronic media.
- Online admissions since 2016 under CBCS.
- The UGC Councelling cell are entrusted to redress issues of students during admissions and proper counselling is done.
- Admissions is open to all. No reservation needed as 100% students enrolled belong to Schedule Tribe, enrollment of women is around 69%.
- 100% scholarship available through Ministry of Tribal and Minority Affairs. It has highest number of beneficiaries in the state.
- Students and their parent/guardian has to submit an undertaking that he/she will not involved in any social, moral evil or ragging activity in the college campus.
- Annual academic calendar is prepared at the beginning of every session.
- IQAC Cell is in accordance with the guidelines of NAAC for development and application of quality benchmarks/parameters for various academic and administrative activities.
- Feedback from students, parents and alumni on the institution and curriculum.
- Organization of inter and intra institutional workshops, seminars and conferences on quality-related themes.
- The college library is fully automised and internet facility made available for students' access. Separate section for Reference Books is established in Library.
- Promotes creativity among students by encouraging them to publish their write-ups in the college magazine and newsletter.
- **Mentoring:** Students are free to approach the teachers for any kind of guidance- personal or professional.
- **Grievance Redresser Cell:**There is a regular, well established and fair proceduref or redressing grievances regarding various matters of the students and the staff.
- Extension lectures by eminent scholars and subject experts.
- A Performa has been designed based on NAAC recommendations and filled by the students to evaluate teachers on the basis of their teaching style, methodology, interaction level etc.This is analyzed by the principal and corrective measures taken to enhance teaching-learning.
- The students can seek accessibility to answer sheet through standard procedure.
- Minimum eligibility to appear in examinations is 75% attendance in the classes for punctuality of students.
- Assess the student weaknesses in the Placement Drives for the last four years through UDAAN Scheme.

- Meritorious students in college and university are felicitated in the college function.

Research, Innovations and Extension

- The departments are involved in conducting research in respective departments and in collaboration with some universities and research centers.
- Research Committee for the purpose of granting Teacher Fellowship scheme is constituted as per UGC norms.
- There are 5 centres established with the effort of teachers and students to undertake minor research work; Centre for Evaluation of physic-chemical analysis of water bodies, hot springs and traces elements, Centre for Health, Culture and Women Welfare, Ladakh Commerce and Industry Research Centre, Centre for Botanical research, Centre for Wildlife Studies and Conservation.
- The teachers are motivated to apply for UGC/DST sponsored major and minor research projects, to conduct conferences, seminars, workshop at national and the international level.
- Regular workshops on Research in Ladakh in collaboration with International Association of Ladakh Studies, Three days Science Awareness Mela from 06th to 8th Sept. 2016.
- Various researchers of eminence are often being invited to deliberate on their subject domains and interact with the students to infuse sense of competition and research temperament among young scholars.
- The science laboratories have been enriched with the support of DST & UGC. These are available to the students and staff for research.
- The library hosts quite a good number of books & journals which can be used by the students & researchers. The library is regularly updated of materials for research as and when recommended by the faculty members of the college.
- The college regularly organizes various extension activities and Institutional Social Responsibility in and outside the campus; Career Counseling by Armed Forces, Awareness on Prime Minister Special Scholarship Scheme, Environment Protection and Prevention of Child Labour, extension lecture on Women Empowerment and Mobility, Conservation Extension lecture by Snow Leopard Conservancy India-Trust, lectures on important national and international days, Swachh Bharat Abhiyan awareness lecture.

The college has developed a very positive relationship with other institutions of the locality for working on various outreach and extension activities. The college invites participants, faculty and prominent citizens from these institutions and the society on the eve of seminars and symposia on social issues.

Infrastructure and Learning Resources

- The development of infrastructure in the institution is being augmented by funds received from the District Plan, UGC funds, RUSA and local funds of the institution, wherever necessary.
- The campus is spread over 31183.37 square meters of land and the current infrastructure comprises of an Administrative Block, Science Block, Commerce Block, Lecture Block, New Lecture Block, Humanities Block, Library Block, Health Center, Gymnasium, Smart Classroom, Computer Lab, Seminar Hall, Botanical Garden/Green House, Canteen, Recreation Hall, Girls Restroom, Rest room for specially-abled students, Toilet Block, Staff Quarter, Girls Hostel and the Tribal Hostel.
- Upgraded laboratories, additional equipments and instruments in labs and computer software

- The library is fully automated using SOUL Software. One SOUL server is connected with three other client computers using LAN networking.
- Tremendous initiative has been taken by the college for improvement of library services. These services include; Reading room, Internet resource cell/Browsing section, Reprographic services, Library Automation and online Public Access Catalogue is installed in the library for searching the library collection in a number of ways.
- The college facilitates use of ICT resources by its staff. Major departments of the college are equipped with desk top computers and broadband connectivity.
- Keeping the students' learning at the centre of everything, the college reorients its teachers from time to time and encourages them to undergo training in computer- aided teaching skills
- Projectors and screens are issued to each department for their use in classroom teaching.
- Water connections of Public Health Engineering are the source of water. Three water tank of 20000 litre capacity each has been constructed for storage purpose. Water Coolers and water purifiers are also installed as a safe drinking water measure in college.
- The college receives 24 hours electric supply from the 10 KV solar plant installed in the college campus hence making the institution a model solar college in the state.
- The college has a development committee, which monitors and maintains infrastructure and learning resource development.
- Strengthening disaster management the college has four bunkers to provide immediate security to students against shelling from across the border.

Student Support and Progression

- College prospectus provides detailed information regarding courses, evaluation system, academic and institutional calendar, scholarships and financial assistance, extracurricular activities, support services, publications, college committees and list of faculty members.
- Admission to SC/ST students is reserved as per norms. The college provides hostel facility to tribal and girl students. 100% enrollment of the college is ST category.
- Students with physical disabilities are provided aid out of college fund..
- Medical facilities to students is provided through its first aid centre.
- Career Counseling & Guidance Cell organizes activities to help students in career development.
- Study tours and exposure trips to the students on regular basis
- Regular workshops on entrepreneurship development motivates the students to become entrepreneurs. The entrepreneurship development agency certifies that most of the beneficiaries of their department are college pass out students.
- Encourages students to participate in co-curricular activities.
- Students participating in sports are provided academic support and individual guidance by faculty members.
- Active participation by students in state and national level competition is encouraged.
- Extends support and guidance to students for PG Entrance examination through organizing Free Remedial Coaching classes.
- Awareness programs are organized to inform students about career in armed forces. Due to such awareness programs large numbers of enrolled students are selected in Indian Army and allied forces.
- Host examination centre for various national level examinations like SSC, UPSC, state and district level exams.

- Experts of various fields are regularly invited to the college campus to deliver lectures for the benefit of students.
- Campus recruitment drive through UDAAN scheme.
- The institution has grievance/redressal cell and women cell to address issues of students in general and girl students in particular.
- Anti-Ragging Committee to curb the menace of ragging. A helpline number is provided at the time of admission to all the new students.
- The college facilitates nomination of economically, socially and educationally backward students for scholarship/financial aid. The college is the top most beneficiary among all the colleges of the state in availing scholarships.

The college seeks feedback on academics/curriculum from the outgoing students and wherever possible, improvements within the purview of the institution are incorporated

Governance, Leadership and Management

- The college management is headed by Principal, involved in coordinating all functions of the college.
- Administration is carried out through constitution of various committees. The Convener of the committees and heads of the department chalk out policies and plans of the institution.
- The plans and strategies meeting for achieving the vision, mission and objectives of the college is held in the beginning of each session under the chairmanship of principal and attendance of all faculty and administrative staff of the college.
- All the heads of the departments and units are authorized to monitor daily functions at departmental level. The decisions taken by them are given cognizance by the head of the institution. An environment of democratic set up is encouraged at all levels.
- The principal convenes regular meeting of the committees and the activities are organized under the leadership of the concerned convener of the committee.
- The student representatives are also involved in matters affecting the students directly. Students are involved in various on -the -campus and off- the- campus activities, by way of creating second tier for participatory management.
- The staff secretary is nominated every year for a smooth relation of the staff with head of the institute.
- The effective and efficient use of financial resources is monitored by the college committee like advisory committee, development committee, and purchase committee with assistance of financial advisor (SO).
- The college accounts are regularly audited internally by the committees and externally through AG office of the state. The college also conducts internal audit through periodic stock verification of various departments and general store. The external audit is carried by a team of auditors from the state government.
- Internal Quality Assurance Cell (IQAC) has been established in the college to maintain and improve its development activities. IQAC meets periodically and assesses the performance of teachers, quantum of syllabus completed, conduct of internal and external practical examinations, mid-term examinations, submission and compilation of awards.

Institutional Values and Best Practices

- The college strives for imparting quality education that is accessible and affordable to the students of the harsh cold, geographically isolated and border district. In these challenging conditions the college provides a serene environment so that each student develops lifelong learning skills, human values and acquire degree that is relevant and useful so that they can compete through their own capabilities and capacities.
- The institute is very sensitive to the environment and environmental issues and works continuously to improve and maintain clean campus. The faculty members, NSS volunteers and students of the college take measures to maintain eco friendly environment within the campus.
- The college is declared as no polythene and no smoking zone.
- Ensuring cleanliness as the top priority the institute has placed biodisposable pits and dustbins in the campus.
- The NSS wings of the college conducts regular visit of NSS volunteers to nearby villages and conduct awareness program among general masses for cleanliness and spreading environmental awareness.
- The college in collaboration of Renewable Energy Ministry, Government of India has installed 10 KV solar plant in the college.
- The college campus has almost no carbon emission as the only source of energy used by the college is solar energy which guarantees zero carbon emission.
- Proper mechanism of water harvesting is observed by the institute by constructing underground water reservoir. The college is in agreement with the villagers for supply of water for plantation purpose.
- The meager electronic waste is disposed off through auction, whenever necessary.
- Apart from the routine curricular, co-curricular and extracurricular activities, the college management is striving hard to introduce various innovative measures to create a positive impact on the functioning of the college.
- The college library has introduced automation of library resources from the year 2015-16 through SOUL software for the purpose. Automation of library resources has enabled easy access to the library resources by faculties and students. The number of walk in has increased tremendously after the automisation of library resources.
- The college has website, facebook page and whatsapp group to disseminate relevant information among student community in particular and public in general.

1.1 Curricular Planning and Implementation

1.1.1 The institution ensures effective curriculum delivery through a well planned and documented process

Response:

- The curriculum is developed by the University of Kashmir to which the college is affiliated. The College committees are entrusted to review the problems faced by the concerned faculties in effective implementation of the curriculum. At the beginning of the academic year a comprehensive plan is formulated and targets are set for the new academic session. Stress is laid upon incorporating innovative methods in teaching learning process (e.g.Group discussions, assignments, presentations etc) to make teaching and learning more interactive and interesting.
- Specific meetings are organized with the faculties in organizing study tours, field survey and field visits in subjects where recommended.
- Academic calendar is prepared and circulated well in time, attendance of students is constantly monitored using Attendance registers.
- Monitoring System and periodic meetings are scheduled that ensure the effective implementation of the curriculum.
- Teachers receive the support required for the effective translation of curriculum and improvement of teaching practices.These include books and journals, internet, computers, stationary, classrooms, laboratories,etc.
- Internet facilities are provided in the library for the assistance of the faculty in curriculum transaction. Projectors for each department are made available and faculties are motivated to use educational DVDS, CDS and documentaries for effective learning of the students.
- Teachers are encouraged to participate in seminars/conferences and workshops to update their knowledge base.They are also trained in General Orientation and Refresher courses in their respective fields.The College administration ensures a congenial atmosphere for optimum teaching-learning.
- The teacher student ratio is maintained by engaging adequate faculty out of Local/Poolfund of the college as per work load submitted by the Head of the Departments. For instance 23 faculties are engaged for current session 2018-19 out of Local/Pool Fund of the college so that the curriculum transaction may be done effectively.
- The college conducts regular internal tests/assignments in order to assess effective curriculum delivery and transaction on the curriculum provided by the affiliating university. Regular study tour and field visits are the special features initiated by the college out of its local fund. For instance more than 25 study tours were conducted in the session 2016-17, and 26 study tours in the session 2017-18 in subjects like Botany, Zoology, Geology, Environmental Studies, Geography and Sociology.
- Time-table and Academic Calendar are followed strictly for class work, internal assessment, examination and evaluation.

2.2 Catering to Student Diversity

2.2.1 The institution assesses the learning levels of the students, after admission and organises special programs for advanced learners and slow learners**Response:**

The college has a provision of classroom tests and quiz through which faculties can identify advanced learners. They are constantly encouraged and guided for preparation of various competitions. Extra support is given to them for participating in symposia, paper presentations, poster presentations, debates and seminars. Learning is made more student-centric by laying stress on specific learning. The most important development in this regard is well furnished reading room in the library block. 2.5 Evaluation Process and Reforms

2.5.1 Reforms in Continuous Internal Evaluation(CIE) system at the institutional level

Response:

- The college organizes interactive session of the faculties and students about the evaluation processes.
- Under Choiced Based Credit system regular assesment mechanism is in vogue at college level whereby students are screened at regular interval before the semester exams.
- The students become eligible to appear in semester examination subject to passing of internal assessment tests which is regulated by the concerned departments. This system has proved fruitful to the institution by way of harnessing regularity and punctuality of the students.
- The results of internal assesment is regularly updated on notice boards of the concerned departments and students are also allowed to see their answer sheets and discuss it with the concerned faculty.
- Affiliating University has housed IT section in the college to facilitate online downloading and submission of examination forms. The practical examination awards are also routed through the same section.
- To ensure the smooth conduct of examination, principal in consultation with the convener examinations assigns duty to teaching and non teaching staff for conduct of examinations.

2.5.2 Mechanism of internal assesment is transparent and robust in terms of frequency and variety

Response:

- The teacher's internal evaluation mechanism is not only for evaluating student performance, but also for initiating measures for bringing about qualitative improvements in the teaching-learning process.
- The college closely monitors the performance of the students through continuous evaluation methods. The evaluation system comprises of internal assessments and a final exam at the end of the session/ semester.
- The college with the consultation of internal assessment and examination committee prepares a calendar of activities to be done regarding the examinations and assessment. At the very outset orientation lectures are conducted at department level in order to inform students regarding the breakup of marks in theory as well as practical.
- Internal assessment in college is so transparent that every student has an idea about the standards adopted in the internal evaluation process of the theory & practical subjects.
- In practicals, slow learners are permitted to improvise their marks by redoing the experiment if they have scored low.
- Similarly, marks obtained by the students in internal assessment test are shown to the students and their satisfaction is ensured accordingly. Heads of the departments are fully empowered to suggest the reassessment of the total marks by the approval of department committee. All such modifications will be displayed in the department notice boards for student reference.

2.5.3 Mechanism to deal with examination related grievances is transparent, time-bound and efficient

Response:

- If a student feels that the marks awarded are not upto his expectation, he may apply for re-evaluation of the papers by depositing prescribed fee within 15 days of the declaration of results to the affiliating university. Scrutiny implies re-evaluation of the entire answer book as well as rechecking of the answer book. Further a candidate can obtain a photocopy of his/her answer script by paying prescribed fees to the university.
- The awards of internal exams are displayed on notice board from time to time and grievances if any is resolved by the examination committee in consultation with the concerned department of the college within a week time from the date of application from students received.
- The aggrieved students may approach HoDs & Teachers at the initial level. If required they may approach Examination Committee, Grievance Redressal Cell or even the Principal. As per University norms, any student can apply for re-checking/re-evaluation of their scripts in case he/she is not satisfied with the result.
- At College level a student if wants may apply for the answer script of the internal exam which is provided on spot return basis to the student. If need arises a committee of subject teacher is formed to redress the issue. Those students who fail the internal exam and apply for re examination to improve results are entertained by the committee and fresh internal exams are conducted for such cases.

2.5.4 The institution adheres to the academic calendar for the conduct of CIE

Response:

- The college is having an annual academic calendar for overall activities of the College.
- The lists of courses for the coming sessions are studied by the faculty of the department. The Head finalizes the course allocation for the faculty members. The faculty members prepare the schedule of work and question paper for internal assessment for their respective courses.
- The evaluation policy for each course is fixed well in advance and communicated to the students at the beginning of the year. Accordingly the coordinator examinations in consultation with heads of departments notifies schedule for conducting internal practical and theory examinations.
- The policy of conducting scheduled internal examination collectively by all departments is practiced. The list of shortage cases is notified well in advance so that such students compensate their shortage before submission of their examination forms.
- The institution faces a few challenges in completing the curriculum within the planned time frame and calendar because of the harsh climatic condition of the area. Delay in declaration of the result by Board of School Education and the University hampers the smooth academic calendar of the college.
- The uncertain situation in Kashmir Valley and prolonged examination due to uncertain strikes add to the problem of completing the curriculum within the planned time.
- The problem is addressed by persuading the university authorities to conduct separate examination schedules for cold zones. The establishment of the sub centre of examination recently at University Campus Kargil and Leh with administrative powers will be a milestone in resolving the grievances

of students in connection with admission, examination and declaration of result.

- The curriculum framed by the Board of Studies of the University clearly states the learning outcomes. All the learners are expected to be sufficiently proficient in their subjects and able to compete in the world outside. Students are acquainted with these learning objectives in the beginning of each session. To share & gather such information is the responsibility of the students as enshrined in the Student Charter.
- The syllabus is structured in such a way that the learners gradually keep growing. Extra-curricular/co-curricular activities are planned by the College to supplement the curricular contents.
- The learners are assessed in various phases viz. Home Assignments, Internal Assessment Phase I, Internal Assessment Phase II, Seminars, Field Projects, External Examination, Re-evaluation etc.
- Teaching-learning & curriculum transaction is highly structured as it is held as per the scheduled time tables & action plans.
- Minimum eligibility to appear in examinations is 75% attendance in the classes. This ensures punctuality and regularity of students.

2.6 Student Performance and Learning Outcomes

2.6.1 Program outcomes, program specific outcomes and course outcomes for all programs offered by the Institution are stated and displayed on website and communicated to teachers and students

Response:

- College website provides a domain for the details of the programmes and courses offered by the college with the further mention of different course combinations in a given programme.
- Further, the contacts of the institution, Principal and concerned committees have been mentioned whereby students or parents can contact for their queries about anything related to the College/College activities.
- Academic calendar for each session is uploaded on website.
- IQAC and other committees give assistance to design the road map for all academic, co-curricular, extracurricular and sports activities into the academic calendar of any given session.
- A copy of time table is also uploaded on the website for students so that they have information about all the courses running in the institution.
- Teachers also introduce the courses to the students with the help of orientation and regular lecture in the classroom.
- The college website committee ensures regular update of information as well as its smooth functioning.
- College Prospectus available on college website provides information to the students about admission process, programmes/courses offered, fee structure, academic calendar, scholarships/financial aid, faculty profile and departmental profiles.
- The schedule of internal assessment of students is uploaded on the website as well as informed by the teachers among the students.

2.6.2 Attainment of program outcomes, program specific outcomes and course outcomes are evaluated by the institution

Response:

- The institution monitors and ensures the achievements of program outcomes, program specific outcomes and course outcomes both by internal and external assessments by following measure:
- The performance of a student who has registered in any of the academic programmes is evaluated internally on continuous assessment basis by the concerned course teacher.
- The process of evaluation includes class tests, class seminars, projects, home assignments, periodical quizzes, laboratory works, seminars, Internal Assessment Tests, University level examination or any other assignment that the teacher considers necessary for assessing the student's performance.
- The distribution of weightage of marks to a theory course is 66.67% and to a practical course is 33.33% in subjects where practical laboratory works are involved. In Arts stream 100% marks is for theory.
- It is made sure at the institution level that students having below 75% attendance should not be considered eligible to appear in the external examinations.
- Continuous assessment is an important component of semester system and it encourages the students to work systematically through out the course.
- Internal Assessment allows in assessing the degree of attainment of course outcome for individual student in a particular course and helps the concerned teacher in going for remedial teaching in case of weak students. The whole process ultimately leads students to have greater understanding of their concerned subjects at the end of semester examinations.
- Assessment of the students is made by way of their performance in their annual examinations which is reflected in results published by affiliating University.
- Meritorious students are awarded proficiency prize in the college.
- Rank holders in the university are felicitated in the college function.
- Placement facility is arranged for students in the college campus.
- The college IQAC initiates and supervises various activities that are necessary to increase the quality of the education and tries to find solutions to issues if any in the working of college.
- IQAC monitors and manages the quality system of teaching, learning and evaluation in the college.
- College faculty members are actively involved in the evaluation of answer scripts of external examinations and some of them act as paper setters for external papers at university level. This allows the college faculty members to experience the weakness/deficiencies in a semester for concerned courses and then try to overcome the same as per the requirements of students.
- Annual results are compiled to assess the pass percentage of students.
- Assessing the student weaknesses is also done by Placement Drives for the last four years through UDAAN Scheme.
- Students' feedback is also considered.

Govt. Degree College was established in 1995 with a sole purpose to impart higher education at undergraduate level to the students of Kargil District. Although situated in a remote, geographically, culturally and ethnically isolated area and with vast scope to undertake research in these areas. There is no formal consent of the University authority to open affiliated research centers in this college. Despite this, the college always promotes and uplifts the innovative temper of the students and helps them to pursue research at the undergraduate level. There are 5 centres established with the effort of teachers and students

to undertake minor research work.

1. **Centre for Evaluation of physic-chemical analysis of water bodies, hot springs and traces elements.**
2. **Centre for Wildlife Studies and Conversation**
3. **Centre for Geological Studies with establishment of a Geological Museum.**
4. **Ladakh Commerce and Industry Research Centre (Micro Level)**
5. **Centre for Botanical research.**

- The teachers are motivated to apply for UGC/DST sponsored major and minor research projects, and to conduct conferences, seminars, workshop at national and the international level. It also encourages the faculty members to attend the same for which college is reimbursing TA/DA as admissible under rules.
- The science laboratories have been enriched with the support of DST & UGC. These are available to the students and staff for research.
- Students are facilitated through subjects tours to visit National Parks and the library hosts quite a good number of books & journals which can be used by the students & researchers. The library is regularly updated of materials for research as and when recommended by the faculty members of the college.
- Various researchers of eminence are often being invited to deliberate on their subject domains and interact with the students to infuse sense of competition and research temperament among young scholars.
- The equipments available in the laboratories can be used by the staff & students for teaching & research. The teaching Departments are responsible for the optimum utilization of equipments in their charge.
- The Science Department was introduced in 2004 and commerce in 2010. Thus it is not be wrong to mention that the college is still in the process of improvement. At present it has a well developed library (APJ Abdul Kalam Library) with more than 12000 books for undergraduate students and faculties of the college.
- Laboratory of respective departments carry on the research work on any topic of their choice with complete freedom.
- Due support is given to the work that involves research oriented academic courses. For e.g. In Ethno-Botanical familiarization project work, under Plant Resource Utilization part of the syllabus, students of B.Sc III year came up with the idea of ethnic food mela, where students hailing from different sub tribes/ area brought homely prepared ethnic food. This not only helped students to understand the importance of indigenous food crop, but also promoted intra-cultural understanding.

3.4 Extension Activities

The institution not only lays stress on academics but also on other extension activities regarding social issues and holistic development.

- The college has NSS units which carry out social out reach programs like campus cleaning and plantation, awareness programs on health and hygiene etc. These activities are reflected in the annual magazine and news letter of the college published from time to time.

- 30 students of the college under the guidance of Sr. Assistant Professor Sociology, Dr. Jaffar Ali Khan and Assistant Professor Chemistry, Mohd Ishaq participated the in the year 2012 and 2014 in Annual Status of Education Report (ASER) facilitated by PRATHAM for voluntaring to help conduct the Annual Status of Education Report (ASER) the largest citizen let education survey in India.
- Community participation is being encouraged under the aegis of NSS. The 100 hours of Swatch

Bharat Summer Internship Programme in the year 2018 was successfully accomplished by adopting various nearby villages and schools for awareness. The villagers were also involved in the process and awareness programs were organized to sensitise the villagers about cleanliness and hygiene.

- The college has developed a very positive relationship with other institutions of the locality for working on various out reach and extension activities. The college invites participants, faculty and prominent citizens from these institutions and the society on the eve of seminars and symposia on social issues. A three day Mega Science Awareness Mela was organized from 6th to 8th of Sept. 2016 by Department of Bio Sciences in collaboration with Jammu and Kashmir Student Welfare Society Anantnag. 120 college students and 80 students from different higher secondary schools participated. 4.1 Physical Facilities

4.1.1 The institution has adequate facilities for teaching- learning. viz., classrooms, laboratories, computing equipment, etc.

Response:

The enhancement of infrastructure in the institution is being augmented by the following:

- The college gets funds from the District Plan. The proposals for augmentation of infrastructure are regularly submitted to the local administration and Higher Education Department of the state.
- The College also approaches and submits proposal to UGC for funding of infrastructure under XIIth Plan.
- College utilizes its own local funds, wherever necessary.
- The college has augmented the infrastructure to keep pace with academic advancement and growth. The campus is spread over an area 31160.8 square meters and the built area is 8286.2 square meters with adequate infrastructure for teaching and learning. This includes lecture blocks, library block, commerce block, science block, humanities block, computer laboratory, smart class rooms and seminar halls.
- Lecture blocks: There are two lecture blocks comprising of 16 class rooms with a capacity of 100 students each.
- Humanities block: The Humanities block has 06 class rooms with a capacity of 80 students each.
- Science block: There is a separate science block consisting of Botany, Zoology, Chemistry, and Physics departments. Each department has upgraded and well equipped laboratory for conducting laboratory work.
- Commerce & Earth Science block: This block accommodates departments of Commerce and Earth Science, Geological Museum, IQAC room and UGC Resource Centre, three class rooms, a computer laboratory for commerce, Counseling and Career Guidance Centre and college IT Hub.
- Library block: The library block is named in honour of honourable former president of India Dr. APJ Abdul Kalam library. The library is fully automated and it has stock of more than 12000 books housed in text and reference sections separately. The block has two reading halls, two seminar halls and Edusat cum Smart Class room facilities.
- Computer Literacy Training Centre: Since 2011 the college in collaboration with Bhavan Gandhi Institute & Information Technology runs special short term/ part time computer literacy certificate programs for the students of the college as well as drop outs.
- Botanical Garden: Keeping in view the harsh climatic conditions of the district as well as the rich medicinal flora, the college has established a model Green House Garden for inducing research aspiration among the students and faculties.

4.1.2 The institution has adequate facilities for sports, games (indoor, outdoor), gymnasium, yoga centre etc., and cultural activities

Sports equipments: The college has full fledged sports equipments and uniforms for various sports like cricket, football, archery, basketball, hockey, volley ball etc.

Game courts: The college has seperate game courts for basketball, badminton and volley ball.

Yoga Centre: The recreation centre of the college provides fully matted facility for the conduct of Yoga programs and Yoga trainings.

Cultural Activities in the College: In order to foster the rich traditional culture awareness among the students the college regularly organise cultural activities in the college under the ageis cultural committee. The college also colloborates on regular basis with Jammu and Kashmir Art & Cultural Academy Government of Jammu and Kashmir in organising cultural events in college campus as well as outside the campus.

The college do initiates promotion of diverse culture of Ladakh such as Balti, Purgi, Sheena and unique Dardi (Aryans) culture by organising exposure trips to in areas of different tribes in Ladakh.

Since the scrutinising pattern of application form and attached documents is internal therefore it is more efficient and less time consuming. Students from remote areas who otherwise fail to meet their academic expenses take benefit out of this aid.

- The vision of this institution is to be a pioneer institute of higher education to provide the students seeking higher education the opportunity to develop creatively and academically. The institution is located in an area which is topographically and geographically isolated and there is a large number of setbacks of the same. The most significant being education and more specifically higher education. Since its inception in 1995 the college has grown in various fields from the number of streams it was offering, the number of permanent faculty to the number of students enrolled which has grown drastically from just 25 students to more than two thousand students, with 69 percent girl enrolment which is an achievement in itself. The institution provides a serene environment to both the genders to grow. The female students specially get the opportunity which this institution in place where they had very less chance of higher education.
- The students from all the strata of society are welcomed in this institution and they get equal access to everything from studies, sports to be a part of NSS to do voluntary service to the society. The introduction of new subjects and the implementation of Choice Based Credit System has enriched the thrust of this institution to provide maximum opportunities to its students.

5. CONCLUSION

- The college is the facilitation centre for J&K Prime Minister Scholarship Scheme in the district. During the past few years has registered and successfully placed more than 1000 students of Kargil in professional and non professional courses in different colleges and universities across the country.
- In order to promote entrepreneurial skills among students and empower them to be job givers, organises regular entrepreneurship development workshops in collaboration Jammu and Kashmir Entrepreneurship Development Institute. During the current academic session, has hosted the first ever START UP INDIA BOOT CAMP in which five startup ideas from the college are selected for state level Boot Camp. In this regard START UP INDIA, Department of Ministry of Commerce & Industry Government of India has appreciated the efforts of the college in successfully hosting the BOOT CAMP in Kargil.
- The college has successfully completed SWATCH BHARAT INTERNSHIP PROGRAM 2018. More than 100 students from the college has contributed 100 hours of volunteer service in far flung villages of the district.
- The college has 69% girls student enrollment and this has been made possible by making access to college easier for girl students coming from far flung villages and has facilitated distribution of Scooties to girl students under J&K Girl Student Scooty Program.
- The College strives for holistic development of students by providing them ample opportunities to participate and represent college at district and state level academic and sports competition events. Our students have brought laurels by winning state and inter university level sports competition.
- Apart from regular undergraduate programs the college offers vocational courses to facilitate the all round development of students.
- In order to instill sense of national pride and patriotism spirit, the college actively involves and encourage participation of students in the celebration Kargil Vijay Divas.
- In addition to regular academic activity the college also offers graduate and post graduate courses, diploma and certificate courses through distance education study centres of Indira Gandhi National Open University, Maulana Azad National Urdu University and Directorate of Distance Education University of Kashmir which enables the working class and thousands who could not afford regular academics.

The college since its inception in 1995 has proved to be a pioneer institute of higher education for the students of geographically isolated and remotest district of the country. Initially it has only Arts stream in the curricula with enrollment of mere 25 students and now the college has introduced commerce and science stream with a dramatic increase of more than 2000 students.

It is a firm conviction of the institution that the growth in infrastructure, academics, research, co curricular and extra curricular activities, activities on social and national issues for creating awareness as well as alleviating the problems, contributions to the local community in terms of various activities-have all been keeping with the expectations of NAAC - a wing of the UGC highly relevant to the present day educational scenario in the country.
